Application for Registration of Discovery Bay Resident's Octopus Card - Terms and Conditions 愉景灣居民八達通卡登記申請條款及細則

- (a) The registration of the Discovery Bay Resident's Octopus Card (DB Resident's Octopus Card) is exclusively for the Owners / Residents of Discovery Bay.
 - 愉景灣居民八達通卡登記申請為愉景灣業主或住客尊享權利。
- (b) The applicant must submit the application form and all necessary supporting documents, as requested under item (c) below, with payment (if applicable) directly to City Management in Discovery Bay Office Centre or Local Management Offices. The applicant will be informed of successful registration. The DB Resident's Octopus Card will be registered and become effective within five (5) working days after the approval of application.

- (g) City Management reserves the right to adjust the number of cards to be registered, the application fee and/or other administrative charges without prior notice.

- (h) Under no circumstances shall Discovery Bay Services Management Limited be held responsible for any damage or loss arising from or in connection with the use of the DB Octopus Card or the card reading process.

These data would not be transferred to other parties without the card holder's prior consent, except that the serial number of the respective Octopus Card may be transferred to Discovery Bay Transportation Services Limited and/or Discovery Bay Transit Services Limited for the purpose of offering privileges and discounts. Terms and Conditions of such privilege and/or discount are subject to Terms and Conditions of the offering companies.
 - Subject to the provisions of the *Personal Data (Privacy) Ordinance*, the applicant shall have the right of access to and correction of his/her personal data.
